MINUTES OF A SPECIAL COUNCIL MEETING  
HELD: MARCH 14, 2019 at 7:00 PM

President of Council Stickan presiding.

PRESENT: Mayor Brunello; Council Representatives: D'Amico, Hargate, Lombardo, Mastrangelo, Murphy, Stickan; Clerk of Council Cahill; Law Director Paluf.

In accordance with Section 4.05 of the Charter, Council Representatives D'Amico, Mastrangelo and Stickan, called a Special Council Meeting to be held Thursday, March 14, 2019 at 7:00 PM for consideration of the following:

Presentations by At Large Candidates

Motion to adjourn into Executive Session by Roll Call vote pursuant to Section 121.22 (G)(1) of the Ohio Revised Code and Highland Heights Charter 4.05 to discuss appointment to council position.

President Stickan stated the purpose of the meeting will be to hold presentations by At Large Candidates. President Stickan thanked everyone for their interest in applying for the open at large position.

The questionnaire was sent which included five questions that Council finalized and will be addressed in the presentation. There is a 5-minute time limit for each presentation. The order of presentations was determined by the date/time the cover letters and resumes were received by the Council Office.

The presentations were as follows:

Cover letters and resumes were also received from: Rose M. Burrello-Gype; Bryan Carr; Gerald L. Sink. These three candidates were unable to attend this meeting and they submitted their presentations in writing. The written presentations were copied and distributed to Council.

Cover letters and resumes were also received after the 12:00 PM deadline on March 8<sup>th</sup>, by Amy K. Dhillon and Elizabeth M. Kryszan. Council determined to consider these applications; however, they were not provided an opportunity to present to council.

Cover letter and resume was also received from Carol A. Ganser who withdrew her application for the open at large council position on March 13<sup>th</sup>.

The candidates addressed Council in the order stated above with their presentations.

President Stickan thanked everyone for their presentation. Ms. Stickan stated Council will adjourn into Executive Session to deliberate on the presentations. The candidates will be informed of the outcome of the deliberations and/or continued selection process.

**MOTION TO ADJOURN INTO EXECUTIVE SESSION:** Moved by Ms. D’Amico to adjourn into Executive Session by Roll Call vote pursuant to Section 121.22 (G)(1) of the Ohio Revised Code and Highland Heights Charter 4.05 to discuss appointment to council position; seconded by Mr. Lombardo.

Mrs. Murphy requested clarification as to who will be attending the Executive Session. President Stickan stated the council members will be in the Executive Session for purposes of deliberation; and the Mayor will be in Executive Session for purposes of observation.

Director Paluf confirmed President Stickan’s comment and added that the Mayor will not be making decisions, however, he is able to participate in the discussion.

Mrs. Murphy stated it is important to have the clarification as the Mayor should not be influencing the Council.

President Stickan stated this is Council’s process and if a decision by Council is not reached, the appointment will be made by the Mayor. Director Paluf stated at this point in time, the candidate appointment is Council’s decision.

Ms. D’Amico questioned if Mr. Paluf would be attending the Executive Session. Director Paluf stated yes, he would be present in the Executive Session.

Roll Call on Motion to adjourn into Executive Session: Ayes: Unanimous. Motion passed.

Council adjourned into Executive Session at 8:15 pm. and reconvened in public session at 10:10 pm.

President Stickan announced Council will be continuing their deliberations. A Special Council Meeting was scheduled for Wednesday, March 20<sup>th</sup> at 7 PM. The Special Council Meeting Agenda will be to adjourn into Executive Session to continue deliberations.
